Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only:</li> <li>Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>Affiliates from using your information to market to you</li> <li>Sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing.</li> </ul>		
Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. COMTRUST Federal Credit Union has no affiliates.		
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</li> <li>COMTRUST Federal Credit Union does not share with non affiliates so they can market to you.</li> </ul>		
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partners include CUNA Mutual Group's MEMBERCONNECT.</li> </ul>
